## Why Invest In Discovery?

### Growing Gold Production in Canada

- Multiple operations in one of the world's most prolific gold camps (~70M ozs since 1910)
- Jan. 2025 Technical Report<sup>2</sup> includes >285 koz/year of average production for next 10 years with significant potential for improvement through investment and drilling
- Potential growth from investment at existing operations and new sources of production, including Dome, TVZ and Hollinger/McIntyre

### Attractive Leverage to Gold and Silver

- Porcupine Jan. 2025 Feasibility Study ("FS") includes net present value ("NPV") of \$4.9B using a fixed \$4000/oz gold price
- Cordero FS included NPV of \$1.2B using silver price of \$22/oz price; NPV increases to \$6.2B using \$75/oz silver (\$7.3B at \$90/Oz Silver)

- Recognized ESG leader in Mexico with numerous environmental and social responsibility distinctions
- Significant investments in mine closure, reclamation and rehabilitation planned to ensure all sites are available for future use by the community

## PORCUPINE COMPLEX

- Jan. 2025 Technical Report estimated average annual production of >285 kozs over the next 10 years with a 22-year total mine life
- Discovery expects to improve on Technical Reports results through investment and drilling to realize the extensive exploration potential in Timmins

## CORDERO

- Among world's largest undeveloped silver reserves (302 million ounces)
- Located in prolific mining belt in northern Mexico
- Permitting process progressing, EIA application submitted in August 2023
- Positive FS results released in February 2024
- 37 Moz silver equivalent production on average Years 1-12, 19-year mine life using FS metal prices
